The Customs and Excise Act (Laws, Volume 18, Cap.322)

The Customs and Excise (Suspension) (Edible Oils) Regulations, 2021

IN EXERCISE of the powers contained in section 89 of the Customs and Excise Act, the following Regulations are made:

1. (1) These Regulations may be cited as the Customs and Excise (Suspension) (Edible Oils) Regulations, 2021.

Title and Revocation

- (2) These Regulations shall stand revoked on 31st October, 2021.
- 2. The customs duty on edible oils shall be suspended to the extent shown in the Schedule.
