## The Customs and Excise (Public Benefit Organisation) (Rebate, Refund or Remission) (Amendment) Regulations, 2022

IN EXERCISE of the powers contained in section 89 of the Customs and Excise Act, the following Regulations are made:

1. (1) These Regulations may be cited as the Customs and Excise (Public Benefit Organisation) (Rebate, Refund or Remission) (Amendment) Regulations, 2022, and shall be read as one with the Customs and Excise (Public Benefit Organisation) (Rebate, Refund and Remission) Regulations, 2009, in these Regulations referred to as the principal Regulations.

- (2) These Regulations shall come into operation on 1st September, 2022.
- 2. Regulations 4 (4) of principal Regulations is amended by the insertion of the following new paragraph immediately after paragraph (b):

- (c) in the case of used clothes, shoes and bags, in Form VII set out in the First Schedule.
- 3. The principal Regulations are amended by the revocation of regulation 6 and the substitution therefor of the following:

Revocation and replacement of regulation

Limitation on quantities of

goods

- 6. The Minister may—
  - (a) limit the quantities of goods on which a rebate, refund or remission may be granted under these Regulations; or

(b) request for additional information relating to the goods for which a rebate, refund or remission is sought.

4. The First Schedule to the principal Regulations is amended by the—

- (a) revocation of Form II and the substitution therefor of the Form set out in Appendix I; and
- (b) insertion of a new Form VII set out in Appendix II.
