The Ministerial and Parliamentary Offices (Emoluments) Act (Laws, Volume 15, Cap. 262)

The Ministerial and Parliamentary (Emoluments) (Amendment) Regulations, 2023

IN EXERCISE of the powers contained in section 2 of the Ministerial and Parliamentary (Emoluments) Act, and after approval by the Emoluments Commission, the following Regulations are made:

1. (1) These Regulations may be cited as the Ministerial and Parliamentary (Emoluments) (Amendment) Regulations, 2023, and shall be read as one with the Ministerial and Parliamentary (Emoluments) Regulations, 2009, in these Regulations referred to as the principal Regulations.

(2) These Regulations are deemed to have come into operation on 1st January, 2023.

2. The principal Regulations are amended by the revocation of the First Schedule and the substitution therefor of the Schedule set out in Appendix I.

3. The principal Regulations are amended by the revocation of the Second Schedule and the substitution therefor of the Schedule set out in Appendix
