STATUTORY INSTRUMENT NO. 4 OF 2024

The Investment, Trade and Business Development Act, 2022 (Act No.18 of 2022)

The Investment, Trade and Business Development (Luano Industrial Park) (Declaration) Order, 2024

IN EXERCISE of the powers contained in section 7 of the Investment, Trade and Business Development Act, 2022, the following Order is made:

1. This Order may be cited as the Investment, Trade and Title Business Development (Luano Industrial Park) (Declaration) Order, 2024.

- 2. In this Order, unless the context otherwise requires— Interpretation
 - "licence holder" means the licence holder specified in the Second Schedule; and
 - "special economic zone" has the meaning assigned to the words in the Act.

3. The area comprising the piece of land described in the First Schedule to this Order, is declared as a special economic zone.

4. (1) The licence holder shall provide, within the special economic zone, infrastructure and facilities which are suitable for

(a) buildings;

(b) electricity;

(c) telecommunication facilities;

- (d) water and waste disposal facilities; and
- (e) roads.

(2) The infrastructure and facilities referred to in subparagraph(1) shall be suitable for the operation of—

(a) garment manufacturing industries;

- (b) packaging materials including corrugated carton box, paper bags and tape manufacturing industries;
- (c) food processing industries;
- (d) electric cables manufacturing industries; and

(e) commercial activities.

5. The goods produced or services provided in the special economic zone may be sold, exported or otherwise disposed of in the ordinary course of business.

special economic zone 6. The licence holder shall not carry out any activity within the special economic zone that is not authorised by a licence or permit granted for the purposes of operations under paragraph 4(2).

7. Goods produced or services provided in the special economic zone may be removed in the ordinary course of business.
